As you may know, the Monterey County Integrated Waste Management Task Force (MCIWMTF) is still active and is meeting on a quarterly basis to discuss waste management issues affecting all of us in Monterey County. Our next meeting is scheduled for 1:30 p.m. on Thursday, May 28, 2009. The meeting will be held in the Monterey Regional Waste Management District Board Room, 14201 Del Monte Blvd., two miles north of Marina.

For the past year, attendance at the MCIWMTF has been low. However, there is one piece of business, approval of the 5-Year Review of the Countywide Integrated Waste Management Plan, which must be approved by a quorum of the MCIWMTF per the Public Resources Code. It is therefore critical that we have a quorum present at this meeting to discuss this matter and other important topics of a regional nature related to recycling and waste management. Representatives from the California Integrated Waste Management Board (CIWMB) will be present to discuss the 5-year review and the new waste diversion reporting requirements of SB 1016.


